Message From CEO

Farm Mechanization and Precision Farming plays a very important role in the context of increasing commercialization of agriculture. Agricultural machinery market in India is estimated to grow at CAGR of over 10% during the period 2013 to 2018. Use of proper equipment can increase the farm productivity by 30% & reduce input cost by 20%. India, with a mechanization level between 40-45 percent, lags in comparison to other BRIC countries such as Brazil and China.



There has been an increase in the use of farm machinery in Indian agriculture as it contributed to the increase in output due to timeliness of operations and increasing precision in input application, ASCI came up with nearly 17 new job roles under the category 'Farm Mechanization & Precision Farming' like Micro Irrigation Technician, Greenhouse Operator, Harvesting Machine Operator etc. With respect to the quality and precision of the operations, which are equally significant for realizing higher yields, ASCI evaluates that there is a strong need for mechanization in agricultural operations & is dedicatedly working towards the development of newer job roles to enhance the farmer's productivity to many folds.

Skilling in Farm Mechanization

Agriculture continues to engage a large population of India, and witnesses a continuous increase in the number of household dependency to 110 Million in 2011 as against 70 Million in 1951. More so, the landless agricultural labour increased in similar proportion to 144.30 million in 2011 as against 27.30 million in 1951. However, on the contrary, agriculture's contribution to the country's GDP remains around 15-16%.

With the changing food plate and consumption pattern that includes dairy, poultry, fruits and vegetables, raises the need for crop diversification and productivity in Agriculture. This compels the development/ upgradation of Indian agriculture. The Indian farmers at the same time, is surrounded by host of uncertainties, such as quality of seeds, chemicals and fertilizers, weather conditions, crop care, timely and adequate rains/ irrigation, post-harvest treatment, processing, market access and more importantly the availability/ usage of appropriate technology and the right equipment throughout.

Over the past decade there has been a strong growth and priority for mechanization. This has led to farm power growth from 1.47 kW/ha in 2005-06 to 2.02 kW/ha in 2013-14. While the farm power remains way below the global average, the farmers are shifting from traditional agriculture to more precision agriculture. The Government of India realizes the need and has taken several measures to promote a structured and scientific intervention in Agriculture. Besides many other initiatives, the Custom Hiring Centers are on the rise through Public and Private partnerships, especially adding value to small land owners, who find ownership of large farm machines expensive and unviable. Academia and Industry are continuously innovating and bringing needed technologies to increase productivity and profitability in agriculture with the aim to minimize drudgery. These high-tech machines and modernization drive in Agriculture needs skilled manpower for optimum resource utilization and efficient use for the desired outcome.

All of this, with the human capital engaged in this field paves the way for modern and profitable agriculture, provided the 'how' part is well addressed. We need to be cognizant of the fact that the farm operation windows are getting shorter due to climate change. Thus, a structured intervention for skill development shall boost this sector both in terms of adaptation of modern practices and utilization of technologically advanced equipment.

We also see a rising trend/interest of women reaching out to learn more precise and modern way of farming. These women aspire to drive tractors and participate in various stages of the crop cycle. Tractor Driving, Ag operations are some areas of interest for women to acquire skills on, which shall change the face of India agriculture. Imagining a day that women in India driving tractors, plowing field, managing crop care and harvesting shall be a powerful story.

The skilling program needs to be in the following areas to make it holistic and sustainable

- Agronomy practices
- Seed / Chemical and fertilizer usage
- Mechanization Land Preparation, sowing, crop care and harvesting
- Water management
- Weather and its impact
- Minor processing/ storage / logistics (minimize wastage at the farm gate)
- Allied farm services
- ▲ Safety in agriculture operations

In times to come with AI, IOT and Big Data, Agriculture shall take another big leap. One must keep that scenario in mind to frame today's program and this should see a smooth transition to the upcoming Agriculture disruptive technologies.





Engagement with Ministry of Agriculture

Skilling under Rashtriya Krishi Vikas Yojana (RKVY)

The aim of Ministry of Agriculture and Farmer's Welfare, through RKVY Scheme, is skilling the rural youth and transferring agriculture latest technology to farmers. Farmers have been involved with greater interest in skill training.

From April, few more institutes have commenced training program with enrolment of candidates from various districts. During 2018-19, a total of 399 Institutes participated under Rashtriya Krishi Vikas Yojana and 15,898 trainees have been trained across 51 Agriculture Job roles. In 2019-20, around 20,000 people are expected to be trained under the scheme.

State Engagement

ASCI's CSR funded training with Jnana Jyothi Financial and Credit Counselling Trust (JJFLCC Trust) to conduct Financial Literacy Training for the Farmers of North Kanara District, Karnataka on Paddy and Sugar Cane Crops. JJFLCC Trust has initiated the implementation of the program at 6 different locations of the district namely, Kumta, Karwar, Bhatkal, Mundgod, Sirsi & Yellapur. The Trust mobilizes nearby village farmers and educating them on Financial Literacy component. So far, the initiative has reached more than 1,011 farmers in 6 different locations.



CSR Project initiated at Uttara Kannada

- ▲ Discussions held with Sri Sadananda Nayak, Managing Director of Odisha Agro Industries Corporation (OAIC) for skill training on Farm Mechanization and demand aggregation. As many machine suppliers are associated with OAIC and there is need of the skilled manpower too, the organization proposed to coordinate with different stakeholders and would provide input for further steps.
- ▲ Discussions held with Project Director of Community Tank Development & Management Society (CTDMS) for their upcoming world bank funded project "Odisha Integrated Irrigation Project for Climate Resilient Agriculture (OIIPCRA)". It's a World Bank and Govt. of Odisha funded project and will be implemented through Department of Water Resources (DoWR). ASCI discussed on available job roles and the mode of operation to the officials.
- ▲ Discussions held with Secretary, Department of Fisheries, Govt. of Assam for the ongoing scheme i.e. Matshya Mitra, Ghare Ghare Pukhuri, Ghare Ghare which focuses on providing nutritional and livelihood support to Fishers by employment generation, enhancing fish production and making the State self-sufficient in fish production by 2020-21 and empowering the rural women through fisheries. The secretary suggested ASDM for STT and RPL proposal submission for Matshya Mitra.
- ▲ Discussions with Tripura Skill Development Mission Director, Ms. Smita Mol IAS, stressed over Industry alignment, development of Poultry value chain and aggregation of Fisheries, Animal Husbandry & Veterinary, Agriculture, Horticulture sectors. Mission proposed for new job roles which are suitable for Tripura like Brooder House Manager, Pineapple Farmer, Pack House Technician and Post-Harvest Technician.
- ♣ Presentation to Fisheries Department, Assam in presence of District Fisheries Development Officers, Joint Director-Fisheries and Director for inclusion of Short Term Training and RPL in the ongoing scheme like Matshya Mitra, "Ghare Ghare Pukhuri, Ghare Ghare Mass". The same has been considered and would enhance self-employability among trained people.

Micro Irrigation Technician, Small Poultry Farmer, Green House operator, Mushroom Grower, Pack House Technician and agreed to include Mushroom Grower & Small Poultry Farmer job roles under current project for Person with disability(PWD) under state funded scheme.

- A Meeting was held with Mr Manoj Kumar Dash, Department of Agriculture, Govt. of Odisha regarding introduction of NSQF approved job roles at their proposed skill training centres at different location of Odisha. - A Meeting was held with Chairman of Seacom Skill University, Mr. Anish Chakravarty for initiating STT and B.Voc, Diploma and Diploma advance at their skill university situated near Shanti Niketan, West Bengal.

Apprenticeship

ASCI has attended Apprenticeship Consultative Meeting organized by FICCI on 16th Apr'19. The meeting was organized under chairmanship of Asst. Secretary General, FICCI, Ms. Shobha Mishra Ghosh and attended by different Sector Skill Councils.

The meeting was organised to know the Apprenticeship implementation status. The SSCs discussed about the optional and designated trades, duration for the Apprenticeship training and the status of the companies to absorb apprentices within the organization. The recommendations and suggestions were noted down by the panel members and will be presenting to the government.

- A SCI participated in Apprenticeship Capacity Building Workshop, organised by NSDC on 30th May'19. The workshop was organised to know the status of Apprenticeship in market, Training Partners concerns, Implementations challenges etc. & to strengthen skills in ecosystem through industry and stakeholders.
- △ One-day workshop on National Apprenticeship Promotion Scheme (NAPS) was organized at Guwahati on 29th May under the aegis of ASDM and FICCI. The workshop saw participation from various industry houses, Agri entrepreneurs and SSCs. ASCI was invited to share its view and way forward on NAPS.
