Agriculture Skill Council of India, is a Government of India notified 'Awarding Body' for conducting assessments and certification of 'Skill Qualification Packs' available in the National Qualifications Register, developed by the council. These standard qualification packs prepared in concurrence with Academia including Schools, Universities, Extension Institutions, Vocational Institutions, Indian Council of Agriculture Research, Line Ministry (Ministry of Agriculture and Farmers Welfare, Ministry of Fishery, Animal Husbandry and Dairying) and industry body and duly approved by overarching Government of India regulatory authority 'National Council for Vocational & Education Training (NCVET)', are developed for vocational education in skilling ecosystem, based on the demand - supply gap in industries and for self - entrepreneurship opportunities.

For imparting standardized and quality training, content for study and utilization by trainees are required to be prepared based on the approved qualification packs and their model curriculums. Interested subject matter experts (SMEs) and other eligible individuals are invited to develop the content on a prescribed format. (It is emphasized that the study material is to be prepared only as per the approved format). Content developers will be paid an honorarium as per the current market trends.

There is No closing date for submission of offer, subject to the Job role not already allotted to another content writer.

The invitation is open to academicians from all the branches of agriculture and allied sciences, viz. Agriculture engineering, crop production, botany, animal husbandry, veterinary, fisheries, dairy, poultry, post- harvest supply chain management, agri commodity, watershed management etc., and those who are interested in writing books, preferably in Indian context.

- The skilling content has to be created in in English and will be subsequently translated to other languages. Preparation of initial content in Hindi can also be considered.
- Duration of modules and the course content has to be prepared as per approved Model Curriculum.
 However, due to the vastness of the Indian Subcontinent and climatic conditions, additional information included in the modules, beyond the Model Curriculum, is always valuable.
- Content development guidelines need to be followed for submitting the content including the 'Table of Content', strictly as per the Model Curriculum and the key learning outcomes.
